

#### FORTNIGHTLY UPDATE - 24.04.2020

Welcome to this latest update. I hope you are all keeping safe.

At a time when a great deal is being written in the press about the national COVID position (some accurate, some less so...) I wanted to say a little bit about the current situation in Cheltenham.

As you know, the central aim of the lockdown strategy has been to slow the spread of the disease, and thereby protect the NHS from being overwhelmed. Thanks to the magnificent efforts of so many, this goal in Gloucestershire is so far being achieved.

Here in our county, the total **number of patients in ITU** at Cheltenham General and Gloucestershire Royal **is 19** (not all COVID-19). Meanwhile, **total capacity in ITU is over 90 beds**, each one equipped with a ventilator for use if needed. We now have five times as many ventilators as we did at the start of lockdown.

This means the Doomsday scenario – of clinicians being forced into heart-breaking choices about which patients should receive life-saving ventilator treatment – has so far been avoided. I want to thank those who have stayed at home and followed the advice.

Earlier today, as every Friday, I had a lengthy briefing with local health chiefs, the County Council, and the other Gloucestershire MPs, to discuss the situation.

Three key messages came to us in that meeting:

(i) **if people are unwell, they shouldn't be afraid to talk to their GP or go to hospital.** CGH and GRH have good capacity to deal with heart attacks, strokes, as well as serious injuries and illnesses <u>READ MORE HERE</u>

(ii) Gloucestershire has managed to secure **PPE** in a timely manner in the main and has met the demand of users - from care homes to funeral directors. In the past week deliveries of more than 446,000 items have been distributed across the county. This doesn't mean we can drop our guard of course (iii) **281 people admitted with COVID-19 have been discharged from Gloucestershire Hospitals** having been successfully treated.

Our thoughts of course remain with the families and friends of those who have very sadly lost their lives. We must in due course come together again as a community to pay tribute and remember them.

#### Ministry of Justice

In my ministerial role, I have been working to deliver a range of measures to address the national impact. These have included **increasing access to legal aid for victims of domestic violence.** I have also authorised the allocation of over £600,000 to boost victims services such as Victim Support, the Survivors' Trust, and sexual violence helplines. And I have signed a Statutory Instrument to allow legal aid practitioners to receive early payment for cases, thereby boosting cash flow at this difficult time. Further details are in the update below.

#### <u>Businesses</u>

Meanwhile, £14.5m in Government grant funding has now been deposited in the accounts of almost 1,200 Cheltenham businesses, in tranches of £10,000 and £25,000.

Also, I am assured after a detailed conversation I held with a High Street bank, that the number of loans approved through the CBILS loan scheme is ramping up.

Meanwhile, the Job Retention Scheme went live earlier this week, with 140,000 business applying for the Government grant on the first day alone. Up to 20,000 workers in Cheltenham alone could be covered by the scheme.

#### <u>Charities</u>

I had a 'meeting' in the last fortnight with the Chief Executive of the **Sue Ryder Leckhampton Court Hospice**, to discuss fundraising and PPE. Many of us (myself included) have had a friend or family member looked after there. We know what skilled and compassionate care it provides.

On the former, following some intensive lobbying, the Chancellor has set up a £750m charity fund, around half of which will be allocated in direct grants, including **£200m to be administered by Hospice UK**. Second, Gloucestershire's local NHS (which provides around a third of Sue Ryder's income) has front-loaded their grant to assist with cash-flow. On PPE, local coordination of PPE supplies through the resilience forum is working well.

I've also had detailed exchanges with Leonard Cheshire, both locally and with their Head Office. PPE supply lines there are also in place.

#### <u>Thank You</u>

Finally, let me pay tribute to those in Cheltenham going the extra mile to support our

fantastic NHS workers. We have our own Captain Tom Moores it turns out!

Stories that caught my eye included the Cheltenham resident, Mike Skidmore, who notionally <u>cycled</u> to the summit of **Mount Everest** from his garage. I also want to thank the 'Food 4 Heroes' volunteers, who stood out in the rain to deliver meals to NHS staff outside Cheltenham General this week.

Thank you too to the workshops at **Balcarras** and **Dean Close** which are churning out visors to aid the national effort.

You've heard our Queen say that "light and life are stronger". We know we'll get through this. And how we do so matters - if we come through it well, this will be in large part because of our NHS and care staff's dedicated service, and the unshakeable support from so many organisations and residents across every square inch of our county. Thank you to you all.

#### CASEWORK

In the last fortnight Alex has received **several thousand emails** and is investigating a wide range of concerns raised by constituents.

Some of the topics he is helping with include:

1. Raising the concerns of **self-employed individuals** who have set up personal service companies and receive payments through dividends

2. Making sure businesses entitled to rate relief and grants get their awards

3. Supporting the travel industry, as well as veterinary and dental practices

4. Connecting offers of help with **medical equipment** - be it manufacturing or supplying - with local and national procurement teams directly.

#### PROTECTING VICTIMS OF DOMESTIC ABUSE

Alex's responsibilities include helping to protect victims of crime, and during the COVID-19 crisis, Alex has been working to ensure that victims of domestic abuse can get the legal remedies and protections they need (including injunctions, non-molestation orders and Domestic Violence Protection Orders).

To that end, on 21 April, Alex signed off measures which will provide **greater access to legal aid** for domestic abuse survivors. The evidence requirements needed to qualify for legal aid have now been expanded, making access easier.

Alongside this, the government has published guidance on applying for domestic abuse **injunctions** remotely. <u>See here</u>

And Alex has worked with colleagues in the Home Office to secure **£2 million** in funding to go towards domestic abuse helplines and online support. <u>Read more here.</u>

The landmark **Domestic Abuse Bill**, which Alex is piloting through Parliament together with Home Office ministers, is also set for its second reading on 28 April. For more detail on what this Bill does, <u>read here</u>.

#### HELPING THE MOST VULNERABLE GET ACCESS TO JUSTICE

Alongside measures to protect victims of domestic violence, Alex has also signed off several other key measures that will help those who need it most.

This includes reinstating immediate **access to individual help** for debt, discrimination and special educational needs (SEN) cases – initially via video link, then face to face when social distancing measures are no longer in place.

The Legal Aid Agency (LAA) will also be given the power to **backdate payments** for applications of legal help for inquests to the time at which the application was made, rather than when the application was granted.

#### ALSO IN THE LAST FORTNIGHT

As part of his other ministerial duties, Alex has:

• Chaired a meeting of the International Law Committee (consisting of Court of Appeal judges, a Law Lord, senior lawyers and others) to discuss progress and strategy regarding the **negotiations with the EU** and member states

- Held talks with Domestic Abuse Commissioner and Victims' Commissioner to brief them on **prisoner release;**
- Introduced measures to support the Legal Aid sector, including expanding the scope for hardship payments in Crown Court cases to reduce the threshold for work done from £5,000 to £1,000, and pausing debt repayments to the Legal Aid Agency for legal firms. Alex is now going further and reducing the threshold to below £500
- Made courtesy calls to the newly-appointed shadow Labour justice ministers

Alex is also responsible for key aspects of 'death management'. He is the Government lead for coordinating funeral industry engagement, industry processes and bereavement support.

# Coronavirus Job Retention Scheme Online service now live

#### UP TO 20,000 CHELTENHAM WORKERS EXPECTED TO BE PAID THROUGH FURLOUGH SCHEME

The Coronavirus Job Retention Scheme (CJRS) went live on Monday 20 April. The CJRS will provide grants to directly pay 80% of employees' wages up to £2,500 per month. Around 20,000 workers in Cheltenham will be covered by the CJRS.

As of 23 April, 387,000 have applied nationally, encompassing almost 3 million workers. The scheme has been extended for a month, allowing employers to furlough staff until the end of June. If you're an employer, you can <u>apply here.</u>

The scheme has also been **expanded to include new starters.** Employers can now claim for furloughed employees that were employed and on their PAYE payroll on or before 19 March 2020.

This change will make an **extra several hundred Cheltenham workers** eligible, and around 200,000 nationally. <u>Read more here.</u>

# **Coronavirus Business Interruption** Loan Scheme

Over 12,000 CBILS loans now approved More than £2bn in government-backed lending

NUMBER OF CORONAVIRUS BUSINESS INTERRUPTION LOANS RAMPING UP

**12,000 Coronavirus Business Interruption Loans** have now been approved, with firms benefitting from **£2 billion** of government-backed lending.

Locally, **Alex had a meeting with HSBC** to discuss his concerns that loans under CBILS were not being made quickly enough to Cheltenham businesses.

HSBC informed him that CBILS was originally rolled out along the lines of the Export Finance Guarantee, meaning that business could only use CBILS if they were 'viable'. Around two weeks ago, **the criteria were relaxed, which has dramatically expanded the availability of CBILS.** Companies no longer have to exhaust all existing company assets before they can make use of it. The definition of 'undertaking in difficulty' (a bar to a loan being made) has been clarified.

#### **OTHER IMPORTANT LOCAL UPDATES**



£750M CHARITY AID TO HELP HOSPICES AND OTHER CHELTENHAM CHARITIES

The Chancellor has announced **£750 million in funding** to prop up charities during this crisis. This is a huge step in ensuring the survival of charities who do vital work. The fund will go to charities including hospices, addressing the recent fundraising shortfall, and many others in Cheltenham and beyond.

#### CHELTENHAM BOROUGH COUNCIL TO BENEFIT FROM ADDITIONAL FUNDING PACKAGE

Last weekend the Government announced a further £1.6 billion of funding for local authorities to use to meet additional pressures arising from the pandemic and **help continue to deliver vital services.** This is on top of £1.6 billion in March, taking the total package to £3.2 billion.

This funding will be un-ringfenced, meaning councils can decide how best to allocate the money. It will support Cheltenham Borough Council and Gloucestershire County Council in delivering vital local services, such as getting rough sleepers off the streets, getting survivors of domestic abuse into safe accommodation, and supporting the shielding programme for clinically vulnerable people. It will also support the continued provision of adult social care and children's services.



#### NATIONAL CYBER SECURITY CENTRE LAUNCH CYBER AWARENESS CAMPAIGN

The NCSC, part of GCHQ, has launched a campaign to help individuals and organisations to protect themselves online, as the country is relying more on technology while staying at home. The 'Cyber Aware' campaign has these top tips for staying safe online:

- 1. Turn on two factor authentication for important accounts
- 2. Protect important accounts using a password of three random words
- 3. Create a separate password that you only use for your main email account
- 4. Update the software and apps on your devices regularly (ideally set to 'automatically update')
- 5. Save your passwords in your browser
- 6. To protect yourself from being held to ransom, back up important data
